

- Pragmatičan pristup
- Nema sveobuhvatnog propisa
- Zuckerberg: “Era of Privacy is over”, 2010.
- Pregovaraju s pozicija da su europska pravila nepotreban administrativni teret i da guše inovacije

# EU

---

- Opći, sustavni pristup zaštiti osobnih podataka
- Zaštita osobnih podataka je temeljno pravo
- Je li izvoz osobnih podataka europskih građana dozvoljen, poželjan, moguć?
- Želja za podizanjem zaštite osobnih podataka na još višu razinu



## Ustav RH 1990., čl. 37.

(1) Svakom se jamči sigurnost i tajnost osobnih podataka. Bez privole ispitanika, osobni se podaci mogu prikupljati, obrađivati i koristiti samo uz uvjete određene zakonom

(2) Zakonom se uređuje zaštita podataka te nadzor nad djelovanjem informatičkih sustava u državi

(3) Zabranjena je uporaba osobnih podataka suprotna utvrđenoj svrsi njihovoga prikupljanja

- Zakon o zaštiti osobnih podataka (NN 103/03, 118/06, 41/08, 130/11, 106/12)
- Kazneni zakon, čl. 146 (125/11, 144/12, 56/15, 61/15)
- Uredba o načinu vođenja i obrascu evidencije o zbirkama osobnih podataka (NN br. 105/04)
- Uredba o načinu pohranjivanja i posebnim mjerama tehničke zaštite posebnih kategorija osobnih podataka (NN br. 139/04)

# Agencija za zaštitu osobnih podataka

---

- Samostalno i neovisno regulatorno tijelo odgovorno Hrvatskom Saboru
- Nadzire provođenje zaštite osobnih podataka
- Vodi Središnji registar

# Agencija za zaštitu osobnih podataka

---

- Rješava povodom zahtjeva za utvrđenje povrede prava
- Edukacija, prevencija, prijedlozi za unapređenje zaštite osobnih podataka
- Ograničen “represivni” aspekt (do sada)

# ZAŠTITA PODATAKA U EU - Pravni okvir star dva desetljeća

---

- **Direktiva o zaštiti podataka 1995**
  - Directive 95/46/EC on the protection of individuals with regard to the processing of personal data and on the free movement of such data
- **Povelja o temeljnim pravima EU**
  - Članak 8 Zaštita osobnih podataka
  - Članak 7 Zaštita privatnosti
- **2009. Lisabonski sporazum**

# Direktiva o zaštiti podataka

---

- **Potrebna implementacija u nacionalni pravni sustav**
  - Kao zakon, npr. hrvatski Zakon o zaštiti podataka 2003. (ZZOP NN 103/03, 118/06, 41/08, 130/11, 106/12) 2003.
  - Njemački *Bundesdatenschutzgesetz 1998*.
  - Irski Data Protection Act 1998.
  - Španjolski zakon 1998

# Direktiva o zaštiti podataka

---

- **Definira ključne pojmove**
  - Osobni podatak, zbirka osobnih podataka, voditelj zbirke osobnih podataka
  - Prepoznaje različite kategorije podataka i kategorije ispitanika
- **Uređuje prava ispitanika i njegovu pravnu poziciju**
  - Traži se jasna, nedvosmislena i konkretna privola na prikupljanje i obradu podataka

# Direktiva o zaštiti podataka

---

- Izvoz osobnih podataka
  - Traži se mišljenje regulatornih tijela, osobito za izvoz izvan EU
- Uspostavlja se mreža nacionalnih regulatora i tzv. Radna grupa iz članka 29. Direktive
  - Tzv. “odluke o adekvatnosti (zaštite osobnih podataka”

# Direktiva o zaštiti podataka

---

- **EU-SAD Safe Harbour Adequacy Decision 2000.**
  - Odluka kojom je EK dopustila izvoz i obradu osobnih podataka europskih građana u SAD
  - Tri izvještaja o primjeni Safe Harboura (EK 02, 04, Galexia report 2008)

# Slučaj Schrems

---

- Slučaj Schrems protiv Povjerenika za zaštitu osobnih podataka (C-362/14)
- Tužitelj traži Sud da preispita valjanost odluke EK nakon što irski regulator odbija prigovor austrijskog korisnika FB
- Sud utvrđuje da EK nije ustanovila SAD poštuje li zakone EU o ZOP
- Obveze primjenjuju samo društva koja su to prihvatila (a mogu kasnije i odustati bez posljedica)
- Ne ograničava pristup američkih javnih vlasti osobnim podacima u skladu s EU zakonima i kompromitira europske principe ZOP
- Kompromitira drugo temeljno pravo iz Povelje – ono na efikasnu pravnu zaštitu.

# EU i izvoz osobnih podataka

---

- Slučaj Costeja C-131/12
  - Sud presudio u korist korisnika i potvrdio tzv. pravo na zaborav, odnosno pravo da fizička osoba zatraži uklanjanje pristupa vlastitim osobnim podacima.
  - Pravo na zaborav se odnosi na uklanjanje ranije javno dostupnih podataka
- Neovisno europsko nadzorno tijelo (*Article 29 Data Protection Working Party*) - Smjernice o implementaciji odluke Europskog suda C-131/12
  - tražilice izjednačene s pojmom voditelja zbirke osobnih podataka iz Direktive
  - potreba iznalaženja pravičnog balansa između temeljnih prava - zaštita osobnih podataka s jedne strane i ekonomskih interesa tražilica i internetskih korisnika na pristup podacima s druge strane

# Google i pravo na zaborav

---

- Nakon sudske odluke, Google je objavio online formular koji korisnicima omogućava da prijave linkove koje žele odstraniti
- U prvih godinu dana, Google je zaprimio preko milijun zahtjeva za uklanjanje rezultata pretraživanja koji vode na osobne podatke
- Preko tisuću petsto zahtjeva dnevno u prvih nekoliko mjeseci primjene

# Remove information from Google

You can ask Google to remove your sensitive personal information, like your bank account number, or an image of your handwritten signature, or a nude or sexually explicit image or video of you that's been shared without your consent, from Google search results.

## What Google will remove

If you want to remove a photo, profile link, or webpage from Google Search results, you usually need to ask the website owner (webmaster) to remove the information.

## Why contact the webmaster?

Even if Google deletes the site or image from our search results, the webpage still exists and can be found through the URL to the site, social media sharing, or other search engines. This is why your best option is to contact the webmaster, who can remove the page entirely.

If a photo or information shows up in Google search results, it just means that the information exists on the Internet and it doesn't mean that Google endorses it.

### What do you want to do?

# Removal Policies

We want to organize the world's information and make it universally accessible, but there are a few instances where we will remove content from Search.

## Legal Removals

We remove content from our search results if it includes:

- Child sexual abuse imagery
- We also remove content in response to valid legal requests, such as copyright notifications that meet the requirements of the Digital Millennium Copyright Act

## Personal information

We may remove certain types of sensitive personal information from Google Search Results.

# Personal information

We may remove certain types of sensitive personal information from Google Search Results.

---

## Information we may remove

### Information we may remove

- National identification numbers like U.S. Social Security Number, Argentine Single Tax Identification Number, Brazil Cadastro de pessoas Físicas, Korea Resident Registration Number, China Resident Identity Card, etc.
- Bank account numbers
- Credit card numbers
- Images of signatures
- Nude or sexually explicit images that were uploaded or shared without your consent

### Information we usually don't remove

- Date of birth
- Addresses
- Telephone numbers

---

## How we decide if personal information should be removed

To decide if a piece of personal information creates significant risks of identity theft, financial fraud, or other specific harms, we ask:

- Is it a government-issued identification number?
- Is it confidential, or is it publicly available information?
- Can it be used for common financial transactions?
- Can it be used to obtain more information about an individual that would result in financial harm or identity theft?
- Is it a personally identifiable nude or sexually explicit photo or video shared without consent?

We apply this policy on a case-by-case basis. If we believe that a removal request is being used to try and remove other, non-personal information from search results, we will deny the request.

**Note:** We usually don't remove information that can be found on official government websites because the information is publicly available.

# Search removal request under data protection law in Europe

## Background

A recent ruling by the Court of Justice of the European Union (C-131/12, 13 May 2014) found that certain people can ask search engines to remove specific results for queries that include their name, where the interests in those results appearing are outweighed by the person's privacy rights.

When you make such a request, we will balance the privacy rights of the individual with the public's interest to know and the right to distribute information. When evaluating your request, we will look at whether the results include outdated information about you, as well as whether there's a public interest in the information — for example, we may decline to remove certain information about financial scams, professional malpractice, criminal convictions, or public conduct of government officials.

You will need a digital copy of a form of identification to complete this form. If you are submitting this request on behalf of someone else, you will need to supply identification for them. Fields marked with an asterisk \* must be completed for your request to be submitted.

# GDPR

---

- **Uredba, a ne Direktiva**
  - Stupa na snagu u svibnju 2018
  - Primjenjuje se izravno, u svim državama Unije
  - Odnosi se na sve organizacije koje prikupljaju osobne podatke na području Unije

# GDPR - Novine

---

- Biometrijski podaci
- Podaci o genetskom profilu ispitanika
- Obveza jasnog informiranja korisnika

# GDPR - Novine

---

- pravo na brisanje podataka (tzv. pravo na zaborav)
- pravo na prijenos podataka od jednog davatelja usluge drugome,
- pravo na obavijest u slučaju napada na podatke,

# GDPR

---

- Koristi za građane
  - Privacy by design
  - Bolja regulacija digitalnih usluga
  - Stroži okvir\*
- Koristi za poduzeća
  - One stop shop i ujednačena primjena
  - Niži troškovi?

# GDPR

---

- Ustanovljava se novo europsko nadzorno tijelo, European Data Protection Board – Europski Odbor za zaštitu osobnih podataka
- Visoke kazne
  - 500 tisuća € do 20 milijuna € ili
  - Od 0.5 do 4% globalnog prometa, već koji je iznos viši

# Privacy Shield

---

- Novi, stroži okvir izvoza osobnih podataka
- Američko ministarstvo gospodarstva će pratiti, a Savezna trgovačka komisija provoditi primjenu EU standarda
- Jasna ograničenja i nadzorni mehanizmi za pristup podacima europskih građana od strane američkih vlasti
- Nakana spriječiti nelegalno masovno nadziranje

# Privacy Shield

---

- Efikasna pravna sredstva
  - Europska tijela za zaštitu osobnih podataka surađivat će s američkim vlastima (DoC i FTC)
  - Besplatan pristup alternativnim mehanizmima rješavanja sporova poput medijacije ili arbitraže
